MINUTES OF MEETING WITH RECOGNIZED NATIONAL & STATE POLITICAL PARTIES HELD ON 10th FEBRUARY, 2022 AT THE CONFERENCE HALL OF CHIEF ELECTORAL OFFICER, MANIPUR AT LAMPHELPAT, IMPHAL CHAIRED BY SHRI RAJESH AGRAWAL, CEO MANIPUR.

2. At the outset, the Chief Electoral Officer, Manipur welcomed all the representatives of political parties present in the meeting and appreciated them for taking active part in the meeting with Hon'ble Election Commission on 7th February, 2022 and highlighted the deliberated on the following points.

I. Nominations:

- a) CEO, Manipur appraised that for the First Phase, a total of 176 candidates had filed nomination papers was conducted on 09-02-2022. He informed that one nomination paper was rejected in 59-Saikot (ST) Assembly Constituency.
- b) He informed that 175 candidates have been validly nominated and the last date of withdrawal is 11-02-2022. The process of Symbol Allotment and List of contesting candidates will be prepared immediately after last date of withdrawal of candidature.
- c) CEO, Manipur informed that for the second Phase, 36 candidates have filed nomination papers till 09-02-2022 and the last date of filing nomination is 11-02-2022 and the date of Scrutiny is 14-02-2022.

II. Publication of criminal antecedents by candidates and political parties:

a) CEO, Manipur reminded that Format C1 is to be published by candidates having criminal antecedents & Format C2 to be published by political parties selecting such candidates on **three** occasions in the one of the following newspapers **AND** one of the TV channels:

 b) CEO, Manipur also specified the timelines for publishing criminal antecedents by candidates and political parties:

1	Within first 4 days of withdrawal of nominations
2	Between next 5 th - 8 th days
3	From 9 th day till the last day of campaign (48 hours before the close of poll.)

III. Expenditure

- a) CEO, Manipur appraised that the inspection of Expenditure accounts of candidates will be done by Expenditure Observers. The schedule of inspection will be notified by the Returning Officers.
- He also informed that candidate may appoint Additional Election Agent to look after the expenditure aspects.
- c) CEO, Manipur informed that Recognised Political Parties must submit their Revised Abstract Statement of Election Expenditure to ECI within 75 days of completion of Elections.
- d) Similarly, unrecognised Political Parties also need to submit their Revised Abstract Statement of Election Expenditure to CEO within 75 days of completion of Elections.

IV. Postal Ballots

a) CEO, Manipur appraised that ETPBS will be dispatched electronically by concerned ROs within 24 hours after the last date of withdrawal of candidature. The total no. of service voters are:
