**PRESS NOTE**

Imphal, the 9<sup>th</sup> November, 2022.

No. 5/ELEC/SSR-2023: As per the schedule fixed by the Election Commission of India, the Draft Photo Electoral Rolls of all 60 (sixty) Assembly Constituencies have been published today, the **9<sup>th</sup> November, 2022** by the concerned Electoral Registration Officers (EROs).

2. The General Public/Electors and representatives of Political Parties may inspect/verify the Draft Photo Electoral Rolls at the offices of the Electoral Registration Officers/Assistant Electoral Registration Officers and with all the Booth Level Officers (BLOs) and they may also visit Chief Electoral Officer, Manipur's website <https://ceomanipur.nic.in> to inspect the Draft Photo Electoral Rolls.

4. The Special Summary Revision w.r.t to 01.01.2023 as the qualifying date starts from today with the publication of Draft Electoral Roll. Detailed schedule is given below:

During this period, one can enrol, delete from, make corrections and apply for shifting of his/her name in the electoral roll. Application forms may be submitted to the Electoral Registration Officers, Assistant Electoral Registration Officers and Booth Level Officers through physical forms. 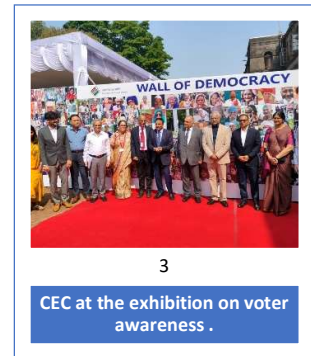
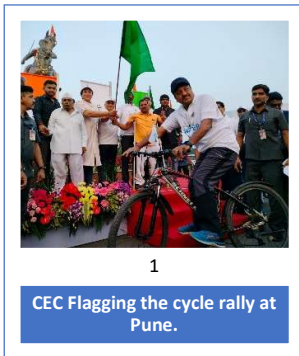
5. To oversee the activities of Special Summary Revision, the following three Electoral Roll Observers have been appointed.

6. According to the recent amendment in Section 14 of the Representation of the People Act, 1950 and corresponding changes in the Registration of Electors Rule, 1960, there are now **four qualifying dates, namely, 1<sup>st</sup> January, 1<sup>st</sup> April, 1<sup>st</sup> July, and 1<sup>st</sup> October.** Applicants, becoming eligible with the prescribed age of 18 years and above with 1<sup>st</sup> January,

2023 as qualifying date and subsequent qualifying dates of the year i.e. 1<sup>st</sup> April 2023, 1<sup>st</sup> July 2023, and 1<sup>st</sup> October 2023 can submit their claims in **Form-6, in advance**, beginning from the date of draft publication of electoral roll (9<sup>th</sup> November, 2022). The applications received related to qualifying date 1st January will be processed as per schedule and electoral roll be updated with final publication. While the forms/claims w.r.t the three subsequent qualifying dates of the year, received in advance, during the SSR period and continuous updation thereafter shall be processed by the EROs under continuous updation during the relevant quarter, preferably in the first month of the quarter.

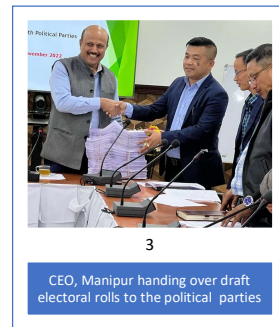
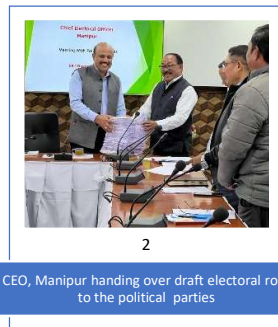
7. Election Commission of India led by Chief Election Commissioner Sh. Rajiv Kumar and Election Commissioner Sh. Anup Chandra Pandey launched today national-wide programme of the Special Summary Revision (SSR2023) for updation of electoral rolls and creating awareness to enrol new eligible voters by flagging off a cycle rally from Balewadi stadium Pune and inaugurated an exhibition on voter awareness messages at Savitri Bai Phule University. The Commission also interacted with Voter Awareness Forum at Hingewadi and hold a press conference. CEC Shri Rajiv Kumar highlighted the importance of SSR during the national launch of SSR2023 from Pune and emphasised focus on enrolment of newly eligible voters, women, PwD voters, & marginalized sections for an inclusive Electoral roll for strengthening of Democracy.



8. Similarly, Chief Electoral Officer, Manipur and Registrar, Manipur University flagged off a Walkathon from Manipur University Gate to Kakwa Bazar with the theme of '**A step for Participative Elections**', organised in connection with the nation-wide launch of Special Summary Revision 2023. Over a hundred participants took part in the walkathon and raised awareness for SSR-2023. CEO, Manipur Shri Rajesh Agrawal appraised the participants about the importance of enrolling all the unenrolled eligible electors and stressed that the young voters can play a vital role in bringing a positive change towards development of the country with a rapid pace.



9. A meeting with all recognised national & state political parties was held on 9<sup>th</sup> November, 2022 wherein they have been briefed about the schedule of Special Summary Revision, 2023. Cooperation was sought from all political parties for enrolling all the eligible citizens. Political parties were also requested to appoint Booth Level Agents (BLAs) for each assembly constituency to facilitate maximum enrolment and transparency. Further, 1(one) printed copy of the Draft Electoral Rolls of each Assembly Constituency and another copy in DVD-ROM was handed over free of cost to the recognised National and State Political Parties. It has been informed that any additional copy can be purchased @ Rs.2/- per page and @ Rs.1/- per half page or part thereof. Interested parties may also purchase it from CEO's Office, Lamphelpat @ Rs. 100/- per DVD-ROM per Assembly Constituency.



10. With the sole objective of giving maximum awareness to the electors, a new **"THE TREND"** campaign under Systematic Voters Education and Electoral Participation has been launched. To create more awareness, 5 State Icons from diverse fields have been identified at the State level and have started engaging them for various awareness activities. Awareness hoardings and posters of SSR-2023 have been put up at strategic locations.
