I am directed to enclose herewith copy of Commission's letter No.76/PPEMS/Transparency/2014 dated 14th October 2014 regarding the above cited subject and to state that the registered unrecognized political parties shall file all reports, namely, (a) the contributions reports in Form 24A, (b) the Audited Annual Accounts, with Auditor report and (c) Election Expenditure Statements, with the Chief Electoral Officer, Manipur.

Further, the last dates for filling of reports/statements by political parties are as under:-

a) Contribution reports - 30th September every year or such date, as extended by CBDT, for filling Income Tax Return.

b) Annual Audited Account - 31st October every year.

c) Statement of election expenditure - within 75 days of completion of Assembly Election and 90 days of completion of Lok Sabha Election.

3. It is, therefore, requested to submit the necessary reports to this office at an early date.
