No. 5/ELEC/WEB-CASTING/SAE/2022: In inviting a reference to this office Notice Inviting Tender No. 5/ELEC/WEB-CASTING/SAE/2022 dated 15th December, 2021 regarding web streaming of video and audio of General Election to Legislative Assembly, 2022, a pre-bid meeting was held on 21st December, 2021 with prospective bidders and the following modifications are proposed to be made to the tender document:

5	6. Supply, Installation and Commission	(a) Delivery	(a) All the ordered items shall be delivered to the local partnership firm within twenty days from the date of work order. The equipments should be installed and commissioned at 5/6 identified places by the CEO's office for checking. The Successful bidder after obtaining the Consignee address shall visit the sites to assess the readiness of the sites for installation at least ten days before the poll. A report in this respect shall be submitted to Election Department.

10	2.1. Conditions of the Consortium Bidders	<p>1) One of the Consortium partners from Manipur shall be nominated as Prime Bidder. The Consortium Agreement in INR 100 non-judicial stamp paper should be entered among the partners. All the signatories of the Consortium Agreement shall be authorized by a Power of Attorney signed by the respective Managing Director or Board of Directors of the Companies/parties to the Consortium. Board Resolution authorising the signatories of the Tender and Consortium Agreement would be accepted.</p> <p>2) The Consortium Agreement shall be submitted in original in the Technical Bid. If the Bid from the Consortium becomes successful, the Consortium Agreement, should be registered in Imphal, Manipur before execution of Contract so as to be legally valid and binding on all the partners.</p> <p>3) All partners of the consortium shall be liable jointly and severally for the execution of the contract in accordance with the contract terms and a statement to this effect shall be included in the Consortium Agreement. The consortium agreement should indicate precisely the role of each partner of the consortium in respect of the contract</p> <p>4) The Prime Bidder shall be authorized by the other Consortium partners to act on their behalf to incur liabilities, to receive instructions for and on behalf of all partners of the consortium, to execute entire contract and to receive payment.</p> <p>5) Only one Bid will be allowed from a Consortium.
