Under section 77 of the R.P. Act, 1951, every candidate at an election is required to maintain a separate and correct account of expenses incurred or authorised by him or his election agent in connection with his election, between the date of his nomination and the date of declaration of the result of the election. The account is to be maintained in the format prescribed by the Commission and the same is required to be submitted to the DEO (R.O. in the case of U.T.) within 30 days after declaration of result of the election. The existing format prescribed by the Commission for maintaining the account of election expenses under section 77 is placed below at F/A.

Recently, some amendments have been carried out to section 77, by virtue of which, all expenditure incurred by political parties, other associations and supporters will all be included in the expenditure of the candidate (the only exception being the expense on the travel of leaders covered under Explanation 2 to section 77 (1). Earlier position was that expenditure incurred or authorised by any political party, association, individual, etc. other than the candidate or the election agent was not deemed to be expenses incurred or authorised by the candidate or the election agent. In view of the amendment now made, detailed information about expenditure by parties, associations, etc. are not required. Therefore, some parts of the existing format relating to details of expenditure incurred by political parties, other associations, individuals, etc. can now be deleted from the format.

A revised format has been prepared in consultation with Legal Counsel, and the same is placed below for kind consideration and approval (DFA-1). The format of the letter addressed by the RO to the candidates regarding filing of account of election expenses has also been modified and is placed below as DFA-2.
